 Councilman Cavazos made a motion to accept the quote from West Tech
 Foundation Repair to install 17 steel push piers for \$11,900.00 and to allow
 \$15,600.00 to be spent on City Hall Foundation Repairs, Sidewalk and
 Incidentals. Councilman Macias seconded the motion. The motion passed
 with a vote of 4/0.
 - D. Consider Request for Water System Improvements
 - Councilman Johnson made a motion to fund \$42,755.00 for water system improvements, to include \$25,500.00 on SCADA equipment and \$17,250.00 for Variable Frequency Drives to control distribution pumps. Councilman Macias seconded the motion. The motion passed with a vote of 4/0.
