- A. Discussion / Action Public hearing on Sub Standard Housing
  - i. Case 20-402 1404 Jerome hear decision from owner on the home. Vicki Carrillo spoke for case 20-402. She would like to find someone to demolish or remove the structure and is asking Council if they could wait until the end of January 2021.

Councilman Johnson made a motion in Case # 20-402 – 1404 Jerome, to accept Vicki Carrillo's request and to give her until January 31, 2021 to find someone to demolish or remove the structure. Councilman Stone seconded the motion. The motion passed with a vote of 3/0.

- B. Discussion Hear comments from John Bradshaw concerning RV Park ordinance issues and drug trafficking in Abernathy John Bradshaw spoke to City Council about two consistent complaints since he has opened his RV Park. One is the amount of criminal activity and the other complaint is about junk. Mr. Bradshaw is asking the police and the city for assistance. Police Chief Villarreal informed Mr. Bradshaw that the area has been patrolled and they will keep patrolling the area. Councilman Johnson informed Mr. Bradshaw they will be looking into a solution.
- **C.** Discussion / Action Resolution 091420 CARES Act funding for Abernathy ISD City Manager Joe Hines and Abernathy ISD Superintendent Aaron Waldrip discussed the CARES Act funding grant with City Council. Councilman Johnson made a motion to approve Resolution 091420 CARES Act funding for Abernathy ISD. Councilman Shannon seconded the motion. The motion passed with a vote of 3/0.
- D. Discussion Abandoning Easements between 206 Main and 803 Ave B City Council discussed abandoning the easements between 206 Main and 803 Ave B.
- E. Review and discuss progress on court room remodels City Council discussed the progress on the court room remodels.
- F. Discussion / Action Seal Coat Project and Funds transfer After discussion, Councilman Shannon made a motion that we do not do this years' seal coat project and to move the money to a separate line item on the FY 2020-2021 Budget. Councilman Stone seconded the motion. The motion passes with a vote of 3/0.

Discussion / Action Ordinance 619 to approve the 2020-21 Tax Rate Councilman Johnson made a motion to approve Ordinance 619 moving that property taxes be increased by the adoption of a tax rate of \$0.5900/\$100 which is a no-new-revenue rate and a 3.32 percent increase in the tax rate. Councilman Shannon seconded the motion. The motion passed with a vote of 3/0. FOR- Councilman Stone, Councilman Shannon, and Councilman Johnson; AGAINST – 0; ABSENT - Councilman Riley and Councilwoman Prater.
