Mayor Webb called the meeting to order.

II. Welcome Guests

VII. Approval minutes of the previous meeting

A. November 9, 2020

Councilman Johnson made a motion to approve the November 9, 2020 minutes. Councilwoman Prater seconded the motion. The motion passed with a vote of 3/0.

Councilwoman Prater made a motion to approve the fleet maintenance report. Councilman Johnson seconded the motion. The motion passed with a vote of 3/0.

 - A. Discussion / Action Exception to Setback and Construction Permit
 - i. 1112 Ave J

Ryan Amundson came to City Council asking for a variance to the setback on a 12x16 shop that he is building inside his fence. He lives on a corner lot and his fence sits right on the property line.

Councilman Riley made a motion to grant the exception for setback and construction of 13 feet for 1112 Ave J. Councilwoman Prater seconded the motion. The motion passed with a vote of 3/0.

- **B.** Discussion / Action Property Demolishing
 - i. 103 S Ave D Demolition
 City Manager Joe Hines informed City Council this was just an informational item and that the property at 103 S Ave D will be demolished.
- C. Discussion / Action EMS Agreement cost increase Councilman Riley made a motion to accept the EMS agreement and allow Mayor Webb to sign it. Councilman Johnson seconded the motion. The motion passed with a vote of 3/0.
- Discussion / Action Letter to inform citizens of permit and setback requirements City Council and City Manager discussed the letter to inform citizens of permit and setback requirements. Councilman Riley suggested the following change to the letter: Any electrical, plumbing, or structural changes to <u>all</u> buildings require a permit. Councilman Johnson made a motion to accept the letter to inform citizens of permit and setback requirement with the one change that Councilman Riley suggested, and to mail out after the first of the year at the City Managers discretion. Councilman Riley seconded the motion. The motion passed with a vote of 3/0.
- E. Discussion / Action Approval of Proctor upsizing agreement. City Manager Joe Hines discussed with the City Council the cost to upsize the Proctor's line from a 6-inch line to an 8-inch line. Councilman Johnson made a motion to expend the money to upsize the waterline from a 6-inch line to an 8-inch line, which is a total cost of \$47,021.76. Councilman Riley seconded the motion. The motion passed with a vote of 3/0.
- F. Discussion / Action Prairie Dog issue at Airport City Manager Joe Hines presented a quote from Panhandle Biological for prairie dog control on 215 acres of the Abernathy Airport property. Councilman Riley made a motion to take further action and to discuss with Dr. Miller a cost share before we progress in the matter and to table to the January 11, 2021 meeting. Councilman Johnson seconded the motion. The motion passed with a vote of 3/0.
