Isabel Ortiz asked City Council for more time to bring Case # 20-403 up to code due to illness in the family.

Councilman Johnson made a motion that in Case # 20-403, 411 Ave J:

- 1. The property is found to be substandard and in violation with city ordinances.
- 2. It is ordered that the structure be repaired or removed within 90 days of notice to the owners, after which time, the City Manager is authorized to abate the conditions thereon.
- 3. Prior to any repairs, demolitions, or removal procedures, any and all required permits for such activities are required through the City of Abernathy.
- 4. That notice of these findings and orders shall be sent to the property owners included within the appropriate code enforcement notice.
- B. Discussion / Action Resolution 020821C Excel rate case
 Councilman Shannon made a motion to approve Resolution NO. 020821C, Resolution
 by the City of Abernathy, Texas ("CITY") approving the surcharge related to docket no
 49831 submitted by southwestern public service company on about December 18,
 2020; authorizing participation in a coalition of similarly situated cities known as the
 alliance of xcel municipalities; authorizing participation in related rate proceedings;
 requiring the reimbursement of municipal rate case expenses; authorizing the
 retention of special counsel; finding that the meeting complies with the open meetings
 act; and making other findings and provisions related to the subject. Councilman Stone
 seconded the motion. The motion passed with a vote of 5/0.

Councilman Riley made a motion to put a job opening for Police Chief on the TML ad base and change the salary to \$60,000 depending on qualifications. Councilwoman Prater seconded the motion. The motion passed with a vote of 5/0.

Councilman Shannon made a motion to schedule a called meeting February 15, 2021 at 5:30 P.M. Councilman Riley seconded the motion. Councilman Johnson made a motion to amend the motion and change the called meeting to Tuesday February 16th at 5:30 P. M. Councilman Shannon seconded the amended motion. The amended motion passed with a vote of 5/0.

Councilman Stone made a motion to nominate Matt Brightbill as Interim Chief. The motion died with lack of a second.

Councilman Riley then made a motion to nominate Bruce Kastning as Interim Chief. Councilman Shannon seconded the motion. The motion passed with a vote of 4/1 with Councilman Stone voting against.
