1. Call to Order

Mayor Johnson called the meeting to order.

2. Roll Call of Council Members

4. Invocation

Councilwoman Prater gave the invocation.

 Councilwoman Prater made a motion to approve the minutes from the previous meeting. Councilwoman Williams seconded the motion. The motion passed with a vote of 5/0.

- Councilman Riley made a motion to approve placement of 911 Antennas on the City of Abernathy's northwest water tower. Councilman Shannon seconded the motion. The motion passed with a vote of 5/0.
- b. Discussion and Action about City of Abernathy and Lubbock Reese Redevelopment Authority *Murvat Musa, CEO of Reese Technology Center* Councilman Shannon made a motion to approve the agreement with Lubbock Reese Redevelopment Authority. Councilman Riley seconded the motion. The motion passed with a vote of 5/0.

Give City Manager guidance on Appropriate Action to Take Councilman Riley made a motion to accept South Plains Waste Services rate increase effective the next billing cycle. Councilwoman Williams seconded the motion. The motion passed with a vote of 5/0.
- d. Discussion about Light Placement at the City Park Russell Rexrode of the Abernathy Baseball Association Russell Rexrode, President of the Abernathy Baseball Association, asked City Council for lights on the baseball fields so that the Baseball Association can host tournaments. He informed City Council that innings do not start after 10 p.m. and lights will be off around 10:30 p.m. City Council asked him to come back with quotes and that there will need to be a separate meeting to give citizens the opportunity to voice their concerns.

 Curtis Childress asked City Council to consider putting a Cul-de-sac at the

end of Avenue J, South of 12th Street and due away with the wall that was placed there. Councilman Riley made a motion to have the City Manager get estimates. Councilwoman Williams seconded the motion. The motion passed with a vote of 4/1 with Councilwoman Williams, Councilwoman Prater, Councilman Riley, and Councilman Shannon voting for and Councilman Stone abstaining.
