  - b. An Action to Ratify the Property Tax Increase Reflected in the FY 2022-2023 Budget

In accordance with Texas Local Government Code Section 102.007 Councilwoman Prater moved to ratify the property tax increase reflected in the budget for Fiscal Year 2022-2023. Councilman Stone seconded the motion. The motion passed with a vote of 3/0/2 with Councilman Stone - Aye, Councilwoman Prater- Aye, Councilwoman Cortez- Aye, Councilman Riley- absent, and Councilman Shannon- Absent.

Action on Ordinance of the City of Abernathy, Texas, Setting and Levying the Municipal Ad Valorem Tax Rate for the Year 2022

Councilwoman Prater moved that the property tax be increased by the adoption of a tax rate of \$0.529314 Per \$100 valuation, which is effectively a 4.26% increase in the tax rate. Councilwoman Cortez seconded the motion. The motion passed with a vote of 3/0/2 with Councilman Stone - Aye, Councilwoman Prater-Aye, Councilwoman Cortez- Aye, Councilman Riley- absent, and Councilman Shannon- Absent.
