- 1. Call to Order Mayor Johnson called the meeting to order.

Discussion and Action about Selecting an Acceptable Bidder for the 500k Ground Storage Tank and Booster Station Project – *Rich Oller, Oller Engineering, Inc* Rich Oller presented council with a bid from Gates Utilities – Dumas, TX in the amount of \$1,375,000.00 and a bid from Brown – McKee Construction Co. – Lubbock, TX in the amount of \$1,275,651.00. Councilman Stephenson made a motion to accept the lowest bid from Brown- McKee in the amount of \$1,275,651.00. Councilwoman Mahan seconded the motion. The motion passed with a vote of 5/0.
