1. Call to Order

Mayor Johnson called the meeting to order at 6:32P.M.

2. Roll Call of Council Members

12. Discussion/Action Items

- a. Consider and take action on Ordinance 635 providing for the sale and issuance of the City of Abernathy, Texas Combination Tax and Revenue Certificates of Obligation, Series 2024, in an amount not to exceed \$1,650,000, to fund water and sewer system improvements; and ordaining other matters relating to the subject.

 Councilman Shannon made a motion to approve Ordinance 635. Councilwoman Cortez seconded the motion. The motion passed with a vote of 5/0.
- b. Consider and take action on Ordinance 634 Alcohol Sales Councilwoman Prater made a motion to approve Ordinance 634. Councilman Shannon seconded the motion. The motion passed with a vote of 4/0. Councilman Stephenson abstained from the vote.
- c. Water Issues Kelly Vandygriff
 Shawn Vandygriff asked the council to consider approval to relocate their meter to a position closer to their property. Councilman Stephenson made a motion to table to the March meeting. Councilwoman Mahan seconded the motion. The motion passed with a vote of 5/0.
- d. Consider Curb Cut Exception Request for Property Located at 1602 Ave L Tyson Rowin Councilman Stephenson made a motion to approve an exception to allow two curb cuts spaced 40 feet apart at 1602 Ave L, which deviates from the city ordinance requiring a 50-foot spacing. Councilman Shannon seconded the motion. The motion passed with a vote of 5/0.
- e. Approval on cost to take down, move, and reinstall Chain Link Fence on Field 2 Councilwoman Prater made a motion to approve budget allocation of \$4,900.00 to facilitate the relocation of the outfield fence on field 2 by February 23, 2024. Councilman Stephenson seconded the motion. The motion passed with a vote of 5/0.
- f. Consider Approval of Funds for GIS Software Councilman Stephenson made a motion to table to the March meeting. Councilwoman Cortez seconded the motion. The motion passed with a vote of 5/0.
- g. Consider and Approval of Purchasing a new printer for City Hall Councilman Shannon made a motion to proceed with a 60-month lease agreement with Visual Edge IT for a Xerox AltaLink C8145 Color Printer. Councilwoman Prater seconded the motion. The motion passed with a vote of 5/0.
- h. Approval of Thunder Pump Service LLC Invoice Councilman Stephenson made a motion to authorize payment of \$13,647.81 to Thunder Pump Service LLC for the installation of the new pump and motor at Well #4. Councilman Shannon seconded the motion. The motion passed with a vote of 5/0.
- i. 2023 Racial Profile Report Chief Dwain Read

Councilman Shannon made a motion to approve the Abernathy Police Department 2023 Racial Profile Report presented by Chief Dwain Read. Councilwoman Prater seconded the motion. The motion passed with a vote of 5/0.

- j. Approval of Oller Engineering Invoices Councilman Shannon made a motion to approve payment of invoices totaling \$15,571.68 to Oller Engineering. Councilwoman Prater seconded the motion. The motion passed with a vote of 5/0.
